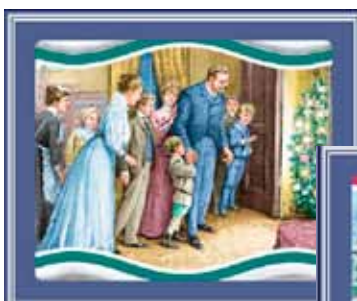
LEGISLATIVE REPORT - C. Elizabeth Holcomb

Legislative priorities at the federal, state and local levels continue to remain steadfastly on jobs and budgets. Creating a healthy business climate for job creation while also finding funds for providing necessary government services is top priority for all levels of government. All eyes are on the Super Committee in Congress, which is tasked with finding ways to rein in an oversized deficit. No major legislation is moving through either chamber while Congress is gridlocked, and this Administration is relying on the federal agencies for promoting its agenda, creating rules with the effect of law without going through the legislative lawmaking process.

In the Virginia statehouse, significant attention will be given to Transportation issues when budgets take center stage in the coming months. Concerns persist at the state and local levels about the serious challenges of trying to balance budgets. On October 4, Governor Bob McDonnell sent a letter to all Virginia local councils announcing his plan to help address

those difficulties. McDonnell announced the Governor's Task Force for Local Government Mandate Review, as provided by Virginia Senate Bill 1452 that passed during the 2011 General Assembly Session. The task force will review state mandates imposed on localities and recommend temporary suspension or permanent repeal of mandates.

The task force is made of five members and includes The Honorable Pat Herrity, Springfield District Supervisor, Fairfax County Board of Supervisors. Alexandria City Councilwoman Alicia Hughes has been asked to serve as the Government Reform Commission liaison. The City of Alexandria responded with mandate recommendations to relieve on November 3, 2011, when Acting City Manager Bruce Johnson submitted Alexandria's input.
